#### FOR IMMEDIATE RELEASE

Three Billings attorneys, all graduates of the Montana State University Law School, will be among the speakers at the 1959 Montana Tax School, according to Prof. Lester R. Rusoff of the law faculty. They are Ben N. Forbes of Sande, Symmes, Forbes and Brown, Sidney P. Kurth of Kurth, Conner and Jones, and Myles J. Thomas Jr. of Coleman, Lamey and Crowley.

The school, set for Nov. 12, 13, and 14 on the MSU campus, is sponsored by the Law School and directed by Rusoff, associate professor of law.

Kurth will speak at 11:05 a. m. Friday, Nov. 13, on "Income Taxation of Estates and Trusts." Before entering practice in Billings, Kurth was tax supervisor of United States Steel Products Co. in New York City.

Thomas will speak at 1:15 p. m. Friday on "Installment Sales of Real Estate and Repossessions." Forbes will follow Thomas on Friday's program. His topic will be "Problems in Acquiring Title to Land."

All three lawyers hold IL. B. degrees from the MSU Law School and LL. M. degrees in taxation from New York University. At the 1957 Montana Tax School Forbes spoke and also led the estate planning panel, and Thomas was a group leader for a discussion on estate planning.

Prof. Rusoff said the Law School annually sponsors the school for lawyers, trust officers, accountants, insurance underwriters, and others concerned with taxation. Persons interested in registering for the school can get detailed information by writing to him at the University, he added.
