Course objectives: This term we will examine the nature of myth and the way it can speak to people in the culture which created it and other cultures like our own. You will become acquainted with the myths of the Greeks and Romans and the deities and heroes who inhabit them. You will investigate some of the patterns which inform various mythologies around the world and see how myth formed the basis for various literary works of the Greco-Roman world. You will read some variants of “mythic accounts” to question their origins and functions and consider how Classical myth has influenced the literary and artistic traditions of the western world. By the end of the course, you will be able to discuss the main points of many of the interpretative frameworks used in the modern world to “explain” various myths, and you will be able to analyze a particular myth in terms of various appropriate interpretative frameworks. You will consider the mythic underpinnings of our own society and your individual “myth.”
