20 with, ASUM in regards to Higher One and the student refund process;

22 Whereas, a clear majority of students on campus prefer a new entity take over the disbursement of
23 refunds to students;

26 distributing refunds to students;

28 Therefore, Let It Be Resolved, that ASUM approves of moving forward with Business Services in
29 order to begin the process of selecting a new entity to distribute student refunds;

31 Therefore, Let It Be Further Resolved, that ASUM intends to work with Business Services towards
32 selecting a new entity to distribute student refunds;
