## Hello Clark Fork and Kootenai River Basins Council members and stakeholders.

Winter is upon us – let's be hopeful for a good water year to come! This last update for 2017 finds the Council in good shape for moving forward with our Work Plan and 2<sup>nd</sup> Annual Meeting in 2018.

Our Natural Systems Health and Water Availability Work Group developed and submitted a letter to the Water Policy Interim Committee at its October meeting that addresses DNRCs reduced funding for stream gauging and the mothballing of several important gauges (<a href="http://mtwatersheds.org/app/news-item/stream-gauges-fall-by-the-wayside-in-state-budget-cuts/">http://mtwatersheds.org/app/news-item/stream-gauges-fall-by-the-wayside-in-state-budget-cuts/</a>).
