# The Fortieth Annual Meet

Abandoned after three years while Montana high school and college youth flocked to the defense of their nation, the Interscholastic Meet is being revived this spring at Montana State University. Those of us at the University who are in charge of the Interscholastic find some significance in the fact that, as the nation passes into a new era of peace and the University into its second half century of service, the Interscholastic begins its fourth decade.

Interscholastic Week has come to be one of Montana's institutions. In three days of varied activity, high school students of the state take part in declamatory and oratorical contests, debate and Little Theatre tournaments, high school newspaper activities and meetings, golf and tennis tournament, and one of the largest interscholastic track and field meets in America.

Through the medium of the Interscholastic Meet, Montana State University manifests its belief in the excellence of the youth of its state. With the Meet it hopes to contribute significantly to the educative process of the secondary schools, and to demonstrate that Montana institutions of higher education are comparable to the best in the nation.


The Interscholastic Committee no longer guarantees repayment to schools of expenses incurred by representatives attending the meet, but prorates such repayments according to the income of the current meet. Details of the plan are given on Page 11 of this bulletin.

Principals or coaches should consult with Professor Thomas in Student Union Office, at 10 a. m. Friday. At that time information can be obtained as to the plan, and possibly as to the amount of the refund to be made.

Please notify the Committee by filling out the proper places on the entry blanks, when you expect to arrive. Those coming by train will be met at stations by members of Tanan-of-Spur and Bear Paw. All attendants at the meet should report at once to Interscholastic Headquarters at the Student Union Building, where quarters will be assigned and badges issued.

1. A contestant will be permitted to enter both the declamatory and athletic contests, the debating and athletic contests, the debating and declamatory contests, or all three, if he so desires. But no more than two contestants from the same school will be allowed to participate in the same athletic event.

2. All contestants will be expected to participate in the events for which they have trained and have entered. No expenses will be paid to a contestant who does not take part in at least one event.

3. It is recommended that principals and coaches enter the men only in the events for which they are best fitted. It is hoped that athletes will specialize in a few events and make good rather than enter many and not qualify. While there is no limit to the number of men who may be listed on the entry blank, not more than 10 from any school will be allowed to participate in the track and field events.

4. In the meeting in the gymnasium on Thursday, May 16, coaches will be expected to scratch entries in the various events for that day. This is for the purpose of saving time in the meet that afternoon.

## Athletics

1. The rules of the National Collegiate Athletic Association will govern all contests in athletics. (Note changes in these rules governing interscholastic competition.)

2. The Meet will be run off in A and B divisions. Any B school desirous of competing in the A division will be permitted to do so, but must make its choice on the entry blanks that will be sent out about April 15. If a B school chooses the A division, it will be declared in every way an A school, and will have no entries in the B division. The A schools must compete in the A division.

3. Attention particularly is called to the following. In the 120yard High Hurdles there is a 15-yard start and finish, and the hurdles are 3 ft. 3 in. high, instead of 3 ft. 6 in. as in earlier years. The distance in the Low Hurdles is 200 yards with an 18-yard start and a 20yard finish. Hurdles are spaced 18 yards. The height remains 2 ft. 6 in. as formerly. The high school 3 lb. 9 oz. discus will be used.

4. Coaches, trainers and attendants will not be allowed on the field during games. Contestants will not be allowed on field unless in uniform. Failure to comply with this rule will disqualify competitors from the school committing the offense.

5. In determining scores for the awarding of prizes in athletics first place in any event shall count five points; second place, four points; third place, three points; fourth place, two points; fifth place, one point. Should the referee declare a tie for any place in any event the point or points shall be divided and a corresponding medal or ribbon given to each contestant.

6. All students certified to take part in this meet must be eligible in accordance with the rules of eligibility adopted by the Montana High School Association and presented in its Constitution and By-Laws.

7. Heats for the 440-yard race will be run on Thursday and only one final race will be run on Friday.

The last events will be the half-mile relays. Two races will be run, one to be made up of entries from Class A schools, the other of entries from Class B schools. Each team will be composed of four runners each of whom will run 220 yards. The baton will be used in the relay race. The committee reserves

the right to qualify more contestants than the above calls for, and to eliminate any semi-final found to be unnecessary.

All 440, 880 and mile races will be started this year at the head of the straightaway (thus eliminating the first turn) with the finish on the far side of the track.

Only contestants in uniform allowed on the field. Coaches, trainers, or others connected with the teams must stay off.

### RULES GOVERNING THE DECLAMATORY CONTEST

1. Note carefully that this year a new procedure is introduced. While both boys and girls may participate, there will be no separate boys' and girls' contests. Instead, three different types of declamation will be presented: serious or dramatic declamation, humorous declamation, and oratorical declamation.

2. Each school may enter a maximum number of three speakers, distributing this number among the above categories in any way the principal or coach desires.

3. There will be preliminary, semi-final, and final contests.

4. A general assembly of contestants, coaches, and judges will be held in the Copper Room of the Student Union Building, Thursday, May 16, at 8:30 a. m., where instructions will be given and contestants sent to their different divisions. All concerned should report promptly. Semi-final contests will be held in the following places immediately after the preliminaries are over: serious or dramatic declamation in the Copper Room; humorous declamation in the Silver Room; oratorical declamation in Library 119.

5. Only six speakers will participate in the final contest Friday evening, and to each of these a medal will be awarded.

6. Declaimers are urged to avoid hackneyed, or intensely dramatic or melo-dramatic selections.

7. No selection may take longer than **ten minutes** to deliver; contestants exceeding this limit will not be considered in choosing winners.

8. The judges shall base their judgment on the speaker's ability to communicate what he has to say. Such communication will depend upon the speaker's understanding and appreciation of the writing, intellectual and emotional, and his impartation of it to his hearers.

This spring both the non-competitive festival and the competitive tournament forms of dramatic participation will be used. The tournament will be open to schools of an enrollment of fewer than 500. Any school may enter the festival. An adjudicator will comment on the festival entrants and judges will judge the tournament entrants. Awards of plaques will be given to the winners of first and second places in the tournament. A medal will be awarded the best actress and the best actor appearing on the evening program, which will be composed of the two winning productions in the tournament and two festival entrants to be selected by an adjudicator. Fifty dollars will be divided equally among the four participants in the evening program. Of this sum half has been generously donated by the Literature section of the Missoula Woman's Club.

The announcement and rules of the tournament and the festival have been given previously in letters sent the director of dramatics in each fully accredited high school of the state. #### PROVISIONS FOR DEBATE TOURNAMENT

1. All high schools, which are eligible to belong to the Montana High School Debate League, shall be eligible to participate in debate. Pairings of teams and determinations of sides shall be by lot.

2. The tournament will begin Thursday, May 16 at 10 a.m. Coaches of all teams will meet in Room 102 of the Library Building for the pairings. Three rounds will be held Thursday with all teams debating. The state championship debate will be held in the Bitterroot Room of the Student Union Building at 6:30 p.m., Friday evening, May 17. (The reason for the early hour is to avoid conflict with the awarding of prizes.)

3. No team will be disqualified in this tournament until it has suffered two defeats. Competent critic judges will decide the preliminary contests, and the final debate will be decided by a group of three expert judges, none of whom shall previously have heard either of the competing teams.

4. Names of all debaters and coaches must be communicated to the Director of the Debate League not later than May 4.

5. Subject to change by mutual agreement of participants and coaches, all debates shall be conducted in accordance with the cross-examination plan provided for in the League constitution. (For regulations regarding payment of expenses see page 13, paragraph 1.)

### PROVISIONS FOR ORATORY TOURNAMENT

1. Orations must be written originally by the students delivering them. The maximum time limit is 10 minutes. Sectioning and speaking order will be determined by lot.

2. The tournament will begin Thursday, May 16, at 1 p.m. Contestants and coaches will meet at 11:30 a.m. in Room 102 University Library, for instructions. Contestants will take part in two preliminary rounds; the winners, not exceeding six, from the preliminary rounds will speak in the semi-finals. Two finalists will be chosen to speak in the final program.

3. Names of all orators and coaches must be communicated to Ralph Y. McGinnis, Montana State University, not later than May 4.

4. For further rules concerning oratory, see the by-laws for oratory of the Montana High School Debate League Constitution. (For regulations regarding payment of expenses see paragraph 1, page 13.)

The Montana Interscholastic Editorial Association will meet in the Journalism building at 8:30 a. m. Thursday and 9 a. m. Friday. Each member school is entitled to two voting delegates, each of whom will receive a contestant badge. After the general session group meetings will convene for advisers, editors, managers and year-book staffs.

The all-state high-school issue of the Kaimin will be published again this year. Staff members, one from each selected paper, chosen on the basis of excellent work during the year, will be notified by letter of their selection to the staff. The editorial staff must report not later than Tuesday noon at the Journalism building; reporters must be on hand Wednesday noon.

Annual newspaper ratings will be announced after the election of officers at the close of the Friday morning session. Awards in this contest will be made upon the basis of the following classification:

Class A-Printed publications from schools with enrollments of 500 or more.

Class B—Printed publications from schools with enrollments between 250 and 500.

Class C—Printed publications in schools with enrollments of 250 or less.

Class D—Duplicated papers from schools with enrollments of 150 or more.

Class E—Duplicated papers from schools with enrollments less than 150.

Class F—Papers which are published as inserts or departments in community newspapers.

Papers in each class wwill be rated Superior, Excellent, Good, Fair," or No Rating.

Delegates will bear their own expenses as in former years.

Gold, silver and bronze medals will be awarded to the winners of the first three places in the boys' golf tournament and a gold medal will be awarded to the winner in the girls' golf tournament.

**Tennis:** Boys' Tournament. Singles and Doubles. Singles preliminaries, Thursday at 8 a. m. to 1:30 p. m., and 4 to 6 p. m. Doubles preliminaries, Friday, 8 a. m. to 1:30 p. m. and 4 p. m. to 6 p. m. Finals, Singles and Doubles, Saturday, 8 a. m. to 1:30 p. m. University Courts.

## Entertainment and Expenses

The Interscholastic Committee does not guarantee repayment to schools for expenses incurred by their representatives at the Interscholastic meet. However, any net income from this year's meet over and above the running expenses is to be made available for such refunds to schools, these refunds to be prorated as a portion of maximum payments outlined below. Every year since the institution of this plan, the refunds have been 100 per cent. It can not now be said whether any portion of this refund can be made within the period of the meet but principals and coaches should consult with Professor Thomas on Friday at 10 a. m. in the Student Union Office.

1. The University will prorate, according to the earnings of the meet, the railroad and/or bus fare based on the shortest route to Missoula and return (meals and sleeper not included) of two contestants (regardless of whether entered in athletics, declamation, or debate) from each of the fully accredited high schools of the state, except as stated in paragraph 2 and in the announcement of Golf and Tennis Tournaments.

2. The University will arrange lodging places for all contestants and their chaperons. If the lodging places provided are occupied, the University will prorate lodging expenses at the rate of seventy- five cents a day at a maximum, for women chaperons and for not more than two contestants from each school. The University will not pay for meals for contestants and chaperons.

3. No schools should send contestants without competent chaperons, one for young women and one for young men, to lodge with them and be responsible for their deportment. No school will be given lodgings without such chaperons; the University does not pay the railroad fare for these chaperons; it offers to women chaperons the same entertainment which it affords to contestants.

4. Contestants' badges and lodging assignments will be given to coaches and women chaperons, who must stay with their teams. Application for these should be made at the Interscholastic Headquarters at the Student Union Building.

5. All coaches, chaperons and contestants will be admitted to all Interscholastic events on presentation of their contestant badges.

6. It will be necessary to lodge the women contestants and their chaperons either in the University dormitories or in private rooms. The men will be assigned lodgings by the committee. Principals and chaperons must assume responsibility for the proper conduct of their students; should hotels prove damages caused by students, or report failure to pay obligations incurred, the right- is reserved to withhold payment of traveling expenses or to refuse admittance to the offending school at future Interscholastic Meets.

7. If two or more schools plan to place their contestants under the supervision of the same chaperon or coach, they must notify the committee not later than the last day set for the receipt of entry blanks. Otherwise it may be impossible to secure lodging for the contestants at the place selected for the coach or chaperon.

## Prizes

### PRIZES IN ATHLETICS

1. The J. P. Rowe Cup, donated by the children of Professor J. P. Rowe in honor of his many years of faithful service to the Montana Interscholastic Meet. The cup will be awarded for the second time this year to the school having the best record in all Interscholastic competition. It will go permanently in 1949 to the school having the best all-events record for five years.

2. The Missoula Mercantile Company presents two cups, one to be awarded to the winner in Class A and one to the winner in Class B. These cups will be awarded each year to the winners of the meet, to be held for one year, and will be awarded permanently in 1947 to the school which shall have won the greatest number of points in five meets.

3. The Kiwanis Cup, given by the Kiwanis club of Missoula, is awarded each year to the team breaking or equaling the largest number of records in the meet. The cup is to be held for one year and will be awarded permanently in 1947 to the team which shall have broken or equalled the largest number of records in five meets.

4. A Rotary cup, given by the Rotary club of Missoula, is awarded permanently to the winning team in each division.

5. Two University Relay cups, given by the University, will be presented to the schools winning the relay races.

6. The University gives gold, silver and bronze medals, suitably engraved, and blue and red ribbons, for winners of first, second, third, fourth and fifth places in all track and field events for both A and B schools—a total of 140 prizes for the 14 athletic events.

7. The University will also give an individual prize to the contestant winning the greatest number of points in each division.

8. In the boys' golf tournament, gold, silver, and bronze medals will be awarded to the winners of first, second and third places, respectively. In the girls' golf tournament, a gold medal will be awarded to the winner. A gold medal will be awarded to the winner in the girls' tennis tournament. In the boys' tennis tournament, three gold medals will be awarded, one to the winner of the singles contest, one to each member of the winning team in the doubles contest, and three silver medals to the runner-up in the singles contest and to each member of the runner-up team in the doubles.

## PRIZES IN DECLAMATION, DEBATE, AND JOURNALISM

1. Gold and silver medals will be awarded in each division; seriious, humorous, and oratorical declamation; and original oratory.

2. A souvenir cup, offered by the University, will be awarded to the winner of first place in the final debate contest.

3. A gold medal will be awarded to the best debater in the final contest.

4. Certificates of Ratings will be awarded in the annual High School Newspaper Contest.

5. The university will present a gold medal to the best actress and to the best actor in the Little Theatre Festival and Tournament.
