10           Whereas, The Associated Students of The University of Montana (ASUM) has informal  
11           lobbying every spring;

12  
13           Whereas, formal lobbying can make informal lobbying redundant;

14  
15           Whereas, informal lobbying can be unproductive;

16  
17           Whereas, Article 6, Section 9, Subsection 9.11 reads:

19                   “9.11 Informal Lobbying. Not less than one (1) hour of informal lobbying shall  
20                   occur after each night of Formal Lobbying.”

21  
22           Therefore, Let It Be Resolved, that Article 6, Section 9, Subsection 9.11 be amended to  
23           read:

25                   “9.11 Informal Lobbying. The Business Manager, in consultation with the  
26                   President and Vice President, may elect to hold one (1) hour of informal lobbying  
27                   which shall occur after each night of Formal Lobbying.”
