11   Whereas Fiscal Policy Section 6.0 addresses the ASUM Recognition;

13   Whereas ASUM bears the financial burden of recognized groups that carry negative account  
14   balances;

16   Therefore, Let It Be Resolved that the following subsection be added to Fiscal Policy Section  
17   6.0:

18                                   “6.5 Student groups that received no ASUM funding during the previous Final Budgeting  
19                                   and have carried over a negative balance from the preceding fiscal year are not eligible  
20                                   for ASUM recognition until the negative balance is corrected.”
