11 Whereas Fiscal Policy Section 10.5 currently allows six (6) Associated Students of The
12 University of Montana (ASUM) departments (ASUM Administration, ASUM Legal Services,
13 UM Productions, ASUM Childcare, ASUM Off-Campus Renter Center and ASUM Student
14 Political Action) to retain unexpended amounts in their respective account at the end of each
15 fiscal year;

17 Whereas two (2) ASUM departments have been added within the last few years, making the
18 current list of departments in Section 10.5 incomplete;

20 Whereas Fiscal Policy Section 11.0 specifically addresses Special Allocations;

22 Whereas Fiscal Policy Section 11.0 does not currently provide explicit instructions with regard to
23 any balance remaining at the end of the fiscal year.

25 Therefore, Let It Be Resolved that the following departments be added to the list of ASUM
26 departments Fiscal Policy section 10.5:

29 be retained in their respective accounts:
