17 Whereas, The University of Montana has taken a strong stance against any form of
18 discrimination through their Non-Discrimination and Equal Opportunity Policy;

20 Whereas, The University’s Diversity Plan instructs The University to provide guidance for
21 students to foster a multicultural society;

23 Whereas, The University, according to their Non-Discrimination Policy, “will protect against
24 retaliation” upon individuals that report discrimination violations;

26 Whereas, past Associated Students of The University of Montana (ASUM) Senates have taken a
27 stance supporting anti-discrimination policies from The University and The University’s
28 Diversity Plan.

30 Therefore, Let It Be Resolved, that ASUM universally condemns any and all forms of
31 discrimination towards current or past students or members of the community;

33 Therefore, Let It Be Further Resolved, that ASUM recognizes and supports all University of
34 Montana students regardless of race, color, religion, sex, national origin, disability, age, creed,
35 marital status, sexual orientation, sexual identity, military service, occupational status, or
36 political ideas;

38 Therefore, Let It Be Further Resolved, that ASUM encourages all members of The University
39 Community to report all incidents and acts of discrimination in accordance with University
40 Policy;

42 Therefore, Let It Be Further Resolved, that ASUM further encourages the creation of and
43 supports plans of action against all forms of discrimination by the ASUM Executives, ASUM
44 Senate, ASUM Committees and ASUM Recognized Student Groups.
