CLEVELAND LAWYER ON MINERAL LAW INSTITUTE PROGRAM

George W. Hazlett, partner in the Cleveland law firm of McAfee, Grossman, Taplin, Hanning, Newcomer and Hazlett, is one of 21 experts in oil and gas and mining law scheduled to speak at the third annual Rocky Mountain Mineral Law Institute, which will be in session at Montana State University, Missoula, August 1, 2, and 3, according to Robert E. Sullivan, dean of the MSU Law School and director of the institute.

The institute is sponsored by the Rocky Mountain Mineral Law Foundation, which was organized in 1955. Its members include law schools, industry associations, and state bar associations in the Rocky Mountain states, and the Mineral Law Section of the American Bar Assn. The yearly institute provides a "continuing education" for practicing attorneys and members of the oil and gas and mining industries, Dean Sullivan said.

Hazlett will speak on Friday, August 2, on "Drafting of Joint Operating Agreements and the Accounting Procedures Used Therein." He holds an A.B. degree from Denison University and an LL. B. from Western Reserve University School of Law. He has been associated with his present firm since 1925. He is a member of the Oil Committee of the Mineral Law Section of the American Bar Assn. and a past member of the Legal Committee of the Interstate Oil Compact Commission.
