**ASUM SENATE MINUTES**  
**Wednesday, October 20, 2010**  
**UC 332/333 - 6 p.m.**

Chair Stovall called the meeting to order at 6:01 p.m. Present: Vice President Stovall, Business Manager Hanson; and Senators Amatuzio, Baker, Berry, Carson, Cochran, DeSoto, Gursky, Gustin, Hoggatt, James, Klapmeier, Mackey, Mariani, Rhea, Sanders, Sims, Spika, Suzuki, Wren and Yerger. Excused: President Williams.

The minutes from the October 13, 2010 meeting were approved.

**Public Comment**

- o Sarah Sather, Bridger Bukantis and Jeff Edmunds provided the update of MontPIRG activities, including a campaign for textbook affordability; a Day of Action, October 21; a "Cap the Rate" campaign to limit pay day loan interest rates; and ongoing election efforts and voting research.
- o Thomas Vincent and Jeff Edmunds talked about the Zoo Crew, a growing group of free style snow boarders and skiers who are preparing to compete around the state and the country.
- o Angie Hundley with the University Center (UC) Student Involvement office provided the update of UC events. Dramatic Influence, a group of Maori singers and dancers from New Zealand will be performing October 21, at 8 p.m. in the UC North Ballroom. The "Take A Break Tuesday" feature will be a program on Wilderness Survival, October 26, from 6 - 7:30 p.m. in UC 330. The Day of Dialogue is Thursday, October 28. The UC is hosting the Association of College Unions International (ACUI) Region 14 conference, October 28 - 30.

**Vice President's Report**

a. Mountainside Chat:

1. Candy Holt, Director of the UC, and Liz Roosa Millar, Associate Director of the UC, provided an overview of: the UC's role on campus; current and pending initiatives and capital improvements; building statistics and the four sources of funding (Exhibit A). There will be an ASUM-sponsored Student Social as part of the ACUI conference, October 28, at 8 p.m. in the Game Room. There will be a commercial vacancy

in the UC beginning next year. Candy is retiring at the end of November and Vice President Branch has not yet announced plans for handling the leadership transition.

- b. There were no committee appointments or removals to report.
- c. Senator Hoggatt will represent ASUM on KBGA, October 21.
- d. Volunteers are still needed Sunday, November 14, to monitor ticket lines for the Griz-Cat football game. Anyone volunteering for two hours or more will be given a ticket for the game. A signup sheet is in the ASUM Administrative office.
- e. Volunteers are needed for the Day of Dialogue, October 28. A signup sheet was passed around.
- f. Senators Sims and Cochran agreed to help with ASUM website updates during their office hours.
- g. Family Weekend is October 22 - 23. Information on the multiple events taking place is available on the UM home page.
- h. Senators are invited to a Child Care "Castle Party," starting at 10 a.m., October 29, in McGill Hall Room 001. Costumes are not necessary.
- i. Vice President Stovall announced a meeting with all committee chairs following the evening's meeting.

**Business Manager's Report - none**

**Committee Reports**

- a. Student Political Action (Gursky) - A forum for candidates running for state offices will be held at 7 p.m., October 26, in Gallagher Business Building room L09.
- b. Board on Members - (Gustin) - A motion by **Suzuki-Hanson** to approve the list of student groups as a slate passed unanimously on a voice vote (Exhibit B). Chair Gustin was part of a group which met with UM Legal Counsel, David Aronofsky, to discuss student group membership criteria. In general it was determined that student groups must accept all comers.
- c. Relations and Affairs (Suzuki) - SB6-10/11 was approved by the committee and given a do pass recommendation.
- d. Students First (Mariani) - The committee met October 15, with Andrea Rhoades who suggested that the committee could accomplish some good ASUM outreach by tabling in the UC Atrium Monday mornings when there is a line to purchase football tickets. Two senators will need to

sign up for each time slot during the next opportunity to table prior to a home football game, November 1.

**Unfinished Business**

- a. A motion by **Suzuki-James** to limit to one minute the amount of time each speaker could have to address SB6-10/11 (Exhibit C) failed 9 - 12 on a roll call vote (see Tally Sheet). A call of previous question by **Amatuzio-Cochran** failed on a voice vote. A motion by **Suzuki-Rhea** to table SB6-10/11 indefinitely passed 14 - 7 on a roll call vote (see Tally Sheet).
