9   Whereas, The Associated Students of The University of Montana (ASUM) pledged to streamline  
10 the budgeting process this fall;

12   Whereas, ASUM budgets for both its own agencies and student groups;

14   Whereas, it is difficult for the ASUM Senate to know what funds exist for student groups if  
15 agencies are not accounted for first;

17   Therefore, Let It Be Resolved, that line 9.12 of ASUM Fiscal Policy be amended to state:

19                   “The Order of Funding Categories. The order of discussion of categories for Final  
20                   Budgeting shall be selected by lottery during the Business Manager’s report no less than  
21                   one (1) week prior to Final Budgeting for all categories, excluding ASUM agencies  
22                   which shall precede all other categories.”
