How best to use the appellate briefs on our web site

Many of you know that the State Law Library digitizes the briefs filed with the Montana Supreme Court, and makes them available to you at www.lawlibrary.state.mt.us. The briefs are linked to the opinions when they are handed down. To read new briefs, select "Montana Supreme Court Opinions/Orders", and then select "Recently Filed Briefs". They are arranged by date.

To search for a particular brief (by party's name, docket number, attorney, or terms), you may either search from the home page or within one of the many files under "Montana Supreme Court Opinions/Orders". Our search engine is not as sophisticated as those used by commercial vendors, but it is fairly effective.

Once you have located the appellate brief you want, you will see that it is in Adobe Acrobat Portable Document File (.pdf) format. If your computer is unable to read the file, go back to the homepage and download the Adobe Reader, at no cost. We encourage you to use the tool bar that appears at the top of the document you have selected. The tools are very useful.

When you click the Adobe "Find" button (large binoculars), a box will appear on your screen. You may enter a word or phrase that you are looking for in the brief. Then click on "Find". The search engine will locate all occurrences of your word, highlighting the first one. To go to the next hit of your search term, click on the small binoculars

.PDF FORMAT is the standard used by most agencies to display documents, as it does not allow for any tampering with the text by users. You can, however, cut and paste words or sections of a .pdf document. Go to your toolbar and click on the "T" box. By holding down on the left button of your mouse, you can scroll through the words of text that you want to save. When you have selected all that you want, click on the right button and select "copy". Then go to your word processing document, and select paste. The language from the brief will appear on your screen.

The button on the toolbar that looks like a magnifying glass does what you think it will do: it will zoom in and out to enlarge or reduce the image in the .pdf document.

TAKE A MOMENT to see what the other buttons on the Adobe Acrobat toolbar can do for you. To get a brief description of a button's function, hover the pointer over it without clicking.

Try them all out. They just might make navigating .pdf documents easier and faster for you.

Book Review: A guide to the state constitution

Few state documents command more reverence than a state's constitution. A constitution expresses how the people wish to organize their government and their relationship to their government. A constitution attests to the character

of the state. It is the organic and fundamental law of the state. People will fight to defend their rights under their constitution and fiercely champion what they believe it stands for, but few actually study the document, its origins and what it means now.

In 1972, Montanans had the opportunity to re-define the state of Montana in a new constitution. The process of drafting and adopting a new constitution – from the election of Constitutional Convention delegates to the final ratification – spurred unparalleled discussion and debate

round the state.

In 2002, the 30th Anniversary of the 1972 Constitution provided Montanans a chance to reflect on how the 1972 Constitution defines Montana thirty years later. The discussion involved fewer people than it did 30 years ago, but the issues were no less significant.

As Montana changes, the discussion must continue, and Larry Ellison and Fritz Snyder's book, "The Montana State Constitution: A Reference Guide," can establish the necessary statewide interest in, and knowledge of our constitution.

Ellison and Snyder write about both the history of the 1972 Montana Constitution, and how we, our legislature, and our courts have amended and interpreted our constitution over the last 30 years. These intertwined discussions provide insight into how the Convention delegates and the citizens of Montana intended in 1972 to define our government and how we define it now.

Ellison and Snyder's text leaves the strong impression that the 1972 Montana Constitution is a unique and powerful document. ○
