9                   Whereas, The Associated Students of The University of Montana (ASUM) is in the  
10                  process of updating its Organizational Personnel Policy;

11  
12                  Whereas, the ASUM Student Resolution Officer is compensated at the rate of “Minimum  
13                  Wage+\$.25” for up to 20 base hours per month, equating to 10 hours per pay period;

14  
15                  Whereas, this position is usually filled by law students, who can make much larger  
16                  salaries elsewhere on the job market;

17  
18                  Whereas, the person filling this position provides a needed service that cannot be found  
19                  elsewhere on campus, helping mediate academic disputes between professors and  
20                  students, or advocating for student rights;

21  
22                  Therefore, Let It Be Resolved, that the ASUM Personnel Policy is amended to increase  
23                  the Student Resolution Officer position’s base hours to “0-30 per month”;

24  
25                  Therefore, Let It Be Further Resolved, that the ASUM Personnel Policy is amended to  
26                  increase the same position’s rate of pay from “Minimum Wage+\$.25” to “Minimum  
27                  Wage+\$1.00”;

28  
29                  Therefore, Let It Be Further Resolved, that these changes will not be implemented until  
30                  the start of Fiscal Year 2014.
