9       Whereas, The Associated Students of The University of Montana (ASUM) is in the process of  
10       updating its Organizational Personnel Policy;

11  
12       Whereas, the ASUM President is compensated for up to 85 base hours per month, equating to  
13       42.5 hours per pay period;

14  
15       Whereas, the ASUM Vice President is compensated for up to 80 base hours per month, equating  
16       to 40 hours per pay period;

17  
18       Whereas, the ASUM Business Manager is compensated for up to 50 base hours per month,  
19       equating to 25 hours per pay period;

20  
21       Whereas, the ASUM Business Manager position is responsible for managing and overseeing the  
22       allocation of hundreds of thousands of student dollars;

24       Whereas, the ASUM Business Manager is an integral part of The University of Montana's  
25       student leadership team, with the ASUM President and Vice President;

26  
27       Whereas, the responsibilities of the ASUM Business Manager have grown over time due to an  
28       increase in organizational budget and student groups;

29  
30       Therefore, Let It Be Resolved, that the ASUM Personnel Policy is amended to increase the  
31       Business Manager position's base hours up to 70 hours per month, equating to 35 hours per pay  
32       period;

33  
34       Therefore, Let It Be Further Resolved, that these changes will not be implemented until the start  
35       of Fiscal Year 2014.
