10   Whereas, The Associated Students of The University of Montana (ASUM) has a vested  
11   interest in timely notification of the resolutions for ASUM Senate meetings;

12  
13   Whereas, ASUM’s website is available to anyone with access to the internet;

14  
15   Whereas, ASUM should conserve paper when possible;

16  
17   Whereas, ASUM should update its by-laws and policies to suit a changing organization;

19   Whereas, Article 1, Section 2, subsection H of ASUM House Rules states:

21               The Vice President shall post, in the ASUM office, a list of all resolutions  
22               submitted for consideration at the next ASUM Senate meeting 24 hours preceding  
23               the meeting. The list shall state the ASUM standing committee to which each  
24               resolution has been referred.

26   Therefore, Let It Be Resolved, that Article 1, Section 2, Subsection H of ASUM House  
27   Rules shall be amended to state:

29               The Vice President shall ensure that the text of all resolutions submitted for  
30               consideration at the next ASUM Senate meeting shall be posted on the ASUM  
31               website 24 hours preceding the meeting, or in the ASUM Office if unable to  
32               update the website. The list shall state the ASUM standing committee to which  
33               each resolution has been referred, if referred to a committee other than the  
34               Relations and Affairs Committee.
