DISCUSSION:

The chairman called the meeting to order. The purpose of the meeting was to finish going through Article 11 for any changes or additions. Mr. Harbaugh's proposal #135 was discussed first, along with #175. Mr. Harbaugh had added the words "public school lands". The main reason he did this was to try to clear up the confusion of public access to these lands. The question was asked if the article were accepted would we have to write a new section for public lands. It was the general feeling that there should be a public lands article. It was suggested that in section 4 to delete the different kinds of classification, and to put the "board of commissioners shall classify or reclassify lands." It was also suggested to add the word "exchange" after the word leaseing. The committee voted on how many wanted an article on public lands. Seven for and 2 opposed.

The number of members on the board was discussed next. 8 voted for an equal number, the number being four.

Article 11, section 5, was next discussed. Mr. Woodsmansey moved that we not look at the financing proposals until after our specific hearing. Motion carried.

Section 6 - delete the words "3 months"

Section 7 - Mr. Noble moved that we delte section 7 and include it in section 1. Motion carried.

Section 8 - proposals #81 and 164 were looked at.

Mr. Harrington's proposal #81 was looked at first. He said he did not believe the state should give any funds to parchoial schools, but he felt federal grants and aids should not be held back. Mr. Harbaugh felt the 1st amendment of the federal constitution should be included, or private schools will all be closed due to lack of funds. Mr. Burkhardt felt that if the first amendment were included, it would defeat the committee proposal.

The committee voted to keep Section 8 as is. 7 for it and 2 opposed.

Mr. Harbaugh's proposal is to leave the section as is, but to add this sentence at the end. "This section does not apply to federal funds administered by the state for the purpose of non-public education."

Mrs. Cain felt the last sentence would make it unconstitutional because you are speaking of federal funds. A tentative vote was taken to see how many were in favor of the proposal. 2 for and 7 against.

Section 9 - okay as it is.
