8       Whereas, The Associated Students of The University of Montana (ASUM) has undergone  
9       a facilitated strategic planning session involving students, student elected leadership, and  
10       ASUM staff;

12       Whereas, five (5) strategic objectives were identified over the course of a semester as a  
13       result of the strategic planning process;

14  
15       Whereas, the ASUM strategic planning process identified strategic initiatives that ought  
16       to provide continuity to our students through flux of leadership;

18       Whereas, Strategic Object 1, Transform ASUM to respond to evolving student needs  
19       identifies an adopted strategic plan each year as a way to remain malleable to student-  
20       identified needs;

22       Therefore, Let It Be Resolved that The Associated Students of The University of  
23       Montana adopts the following subsections under Article IV – Committees and Boards,  
24       Section 17, of the ASUM Bylaws:

26               E. The Chair of the Board on Off-Campus Housing and Neighborhood Outreach,  
27               in coordination with the ASUM Off-Campus Housing Director, shall present an  
28               annual report identifying the achievements and areas of potential growth of the  
29               administration to reflect current student needs.

31               F. The Chair of the Board on Off-Campus Housing and Neighborhood Outreach,  
32               in coordination with the ASUM Off-Campus Housing Director, shall present a  
33               full evaluation and a specific five-year strategic plan to address identified student  
34               needs every five (5) years.
