8       Whereas, The Associated Students of The University of Montana (ASUM) has undergone  
9       a facilitated strategic planning session involving students, student-elected leadership, and  
10       ASUM staff;

12       Whereas, five (5) strategic objectives were identified over the course of a semester as a  
13       result of the strategic planning process;

14  
15       Whereas, the ASUM strategic planning process identified strategic initiatives that ought  
16       to provide continuity to our students through flux of leadership;

18       Whereas, Strategic Object 1, Transform ASUM to respond to evolving student needs  
19       identifies an adopted strategic plan each year as a way to remain malleable to student-  
20       identified needs;

22       Therefore, Let It Be Resolved that The Associated Students of The University of  
23       Montana adopts the following subsections under Article IV – Committees and Boards,  
24       Section 1, of the ASUM Bylaws:

26               M. The President, in coordination with the Vice President and Business Manager,  
27               shall require each agency, through the direction and assistance of the agency’s  
28               oversight board, to compile a full evaluation of the agency in order to assess how  
29               the agency meets current student needs and identify an agency specific five-year  
30               strategic plan to address identified needs.
