162 April 7th 1900

Immediately after convocation the Faculty met in special session to consider a request of the Athletic Association for permission to give an entertainment. On motion the matter was referred to a com. — Profs. Mer, Elrod and Keiley were appointed the com. — After which the meeting adjourned.

163 April 8th 1900

A special meeting was called at 4¹⁵ P. M. The reading of the minutes of the previous meeting was dispensed with. —

Com. appointed on Ap. 4th made its report. the same was read. — Moved to adopt. Sec. Car'd.

Resolution presented by Prof. Smith was read to investigate the claims of Mr. Cleveland. — amended to ~~add the~~ Faculty director and Pres't of the University. — ^{to the com.} amendment carried.

The resolution was adopted. —

Petition was read from Mr. W. J. McComick asking for reinstatement; his suspension being caused by 3 unexcused absences from Gymnasium practice. — M. 7. carried that Mr. McComick be reinstated on trial with three

absences not excused.

Petition read from Mr. Elmer Woodman asking for reinstatement - suspension caused by 3 unexc. absences from Gymnasium. - Discussed. - Moved to reinstate Mr. W. on trial with his absences not excused. - 2d. Carried. -

Mr. W. Reed having 3 unexcused absences, is reported suspended by his own act. -

Moved to adjourn. - Seconded. - Carried. -

165 April 20th - 1900. -

Report of the Com. to investigate Mr. G. Cleveland's claim read. - ^{M. to accept report.} Moved that the faculty advise the Directors of the Athl. Ass'n that they believe the claim of 2⁰⁰ for football made by Mr. Cleveland ^{to be} just. - 2d. Carried.

Moved that the ^{new} catalogue ^{to} be discussed arranged at the next meeting. - and the material to be

arranged by the following:

- The Prof. of Mathematics - to arrange Calendar.
- + Equipment, Math. work and courses of instruction
- " " of Biol. Equipment, courses in Biol. & + Museum.
- " " Chemistry. Equipment + courses in Chem. Phys. Geology, Assaying, Miner.
