The ELEVENTH meeting of the General Government and Constitutional Amendment Committee was called to order by Chairman Etchart at 10:10 a.m. Tuesday, February 1, 1972 in Room 410. Roll call was taken and the minutes of the last meeting were read and approved.

Delegate Proposal No. 27 is going to be incorporated in Mr. Habedank's Proposal.

Mr. Brown moved that Mr. Grady, our research analyst, rewrite Proposal 36 to incorporate Article V, Section 46 and then bring it back to the committee for further approval. It was seconded and carried.

Mr. Habedank read his proposal on Article XIX, Sections 8 and 9 and he explained why he wrote it the way he did.

A discussion was held as to whether a recess should be taken or not. No definite decision was made. It was the feeling that it wouldn't be a bad idea if Style and Drafting needed the time to get through the material.


The subject of when the constitution would be presented to the public was brought up. It was the feeling that if it could be ready by the primary election that would be the best.

Mr. Brown presented his proposal on suffrage to the Bill of Rights Committee and they unanimously approved it.
