The TWENTIETH meeting of the General Government and Constitutional Amendment Committee was called to order by Chairman Etchart Friday February 11, 1972 at 9:30 a.m. in Room 410.

Mr. Choate moved that the majority report favor deletion of any reference to the boundaries in the constitution. Mr. Lorello seconded the motion. The motion passed with Mr. Harlow and Mr. Belcher dissenting. They will make a minority report on boundaries using Mr. Stamm's wording.

There was a good deal of discussion on Delegate Proposals 112 and 157. The general feeling was the proposals concern a legislative matter but the topic was tabled for now.

Mr. Choate moved that Proposal 139 not be adopted since it is adequately covered in Article X, Section 1 of the present constitution. Mr. Harlow seconded the motion. The motion passed with Mr. Lorello dissenting.

Mr. Harlow moved that Delegate Proposal 115 not be adopted. Mr. Habedank seconded the motion and it carried.

The meeting adjourned at 11:40 a.m.
