MINUTES OF THE THIRD MEETING OF JUDICIARY COMMITTEE

DISCUSSION: This meeting was held for the purpose of setting up a schedule of matters which the Committee is to consider at the 2:00 p.m. meeting of this date. Chairman Holland proposed that the Montana consistution and the Montana Plan be discussed and considered as it presently is written today. It was agreed by the members that such would be considered in great detail.

The Committee agreed to cancel the hearing which was noticed for January 22 and 24, 1972 and reschedule the same for Tuesday. It was again discussed by the committee that a letter should go
