Three Montana business and professional men will be on the program of the second annual Management Seminar for the Montana Grocery Industry at Montana State University, Missoula, July 13, 14, and 15, Dr. John S. Wright of MSU, conference director, announced Saturday.

Hugh Galusha, Jr., Helena lawyer and certified public accountant, will speak on "Income Taxes," and E.L. McIntosh, division manager of Safeway Stores, Inc., Butte will speak on "Employee Training." Paul Mateucci, president of Super Save Markets, Great Falls, will lead a discussion on "Promotional Plans Used by Montana Grocers during the Last Year."

The seminar, sponsored by the MSU School of Business Administration in cooperation with the Montana Food Distributors Assn., will also take up financing of small businesses, psychology in selling, trading stamps, and other topics of interest to the grocery industry.

Galusha is a partner in the accounting firm of Galusha, Higgins and Galusha and in the law firm of Galusha and Meloy. He is a director of the Yellowstone Park Co., Eddy Bakeries Co., and the Union Bank and Trust Co. In his professional work he specializes in tax practice.

McIntosh rose through the ranks of the Safeway organization from meat cutter to his present position as division manager. He came to Butte in 1957 from Dallas, Tex., where he was employee relations and retail operations manager. In his present post he is in charge of all Safeway activities for the Butte division, which includes all of Montana and four counties in Wyoming.

Matteucci, a member of an old-line Great Falls retailing family, operates a shopping center in Great Falls and is building a 22,000 square-foot super market there. He also has business interests in Havre and Helena. He spoke on "Non-Food Retailing in Grocery Stores" at the recent national convention of the National Assn. of Retail Grocers of the United States.
