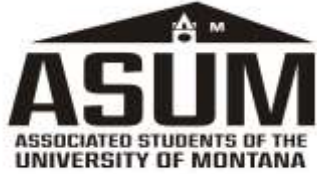

Wednesday, February 14th, 2018

Chair Love called the meeting to order at 6:00 p.m. Present: Senators Belcher, Butler, Capece, Carpenter, Corkish, Cowley, Curtis (6:02 p.m.), Durnell, Fitzpatrick, Hiatt, Hohenstein (left at 9:10 p.m.), Koerber, Milton, Morrill, Parsons, Quist, Schafer, Stokovich, Toppen, Welch (left at 9:10 p.m.). President Fitzgerald, Vice-President Love, Business Manager Kuiper, Advisors. Stark and DeBoer. Unexcused: Senators Anderson, Bornstein, Borstad, Lemm, Lewis,

The minutes from the February 7, 2018 meeting were approved.

Public Comment

- Representatives from the Whitewater Club spoke to the senate about their Travel Allocation request for their rafting trip on the Lochsa river. They need the funding in order to take students out rafting and give them that experience. They will be taking around 10 to 20 students on their trips throughout the semester.
- Heidi Dreher from Global Grizzlies spoke to the senate about their Travel Allocation Request for their trip to Uganda. She expressed her happiness with the amount that the Board on Budget and Finance recommended.
- Shelby Weigand came to express her happiness about the amount the Board on Budget and Finance recommended for their Travel Allocations Request for their trip to Wyoming. They would like to get a little bit more towards gas, however.
- Koleena Shear from Anime Club spoke to the senate about their Travel Allocation Request. They need the money for a trip to Washington for a convention. She was concerned that the recommended amount would not be enough to fund the hotel rooms they need on their trip. Business Manager Kuiper clarified that in fiscal policy ASUM is restricted to funding at a maximum of \$400 for lodging.
- Genevive Barlow from University Player spoke on a proposed amendment to fiscal policy section 9.6. She asked for a senator to help her make a resolution to amend these bylaws to include a section creating an alternative solution for groups who missed communications about the required information sessions. She asked that one of the senators make a motion to repeal the decision to not allow the group to make up for their missed sessions and be eligible for budgeting.
- Kelly Williamson spoke to the senate about the new set-up for graduation. She has heard several students issue concerns about holding two ceremonies in the Adams Center rather than dividing it up by departments. President Fitzgerald said he would share these concerns with the planning committee and advised her to speak with Rebecca Powers.
- Carly Stinson from the Woodsman Team spoke to the senate about their Travel Allocation Request for their trips to different colleges around the nation for demonstrations.

- Dean of Students, Rhondie Vorhees, spoke to the senate on the different offices in the university, and the structure of the university as a whole. She also spoke on the speech by Mike Adams speech last night. She explained some of the planning and security around the event.
- The President of UM Dance Club spoke to the senate on their Travel Allocation Request. He asked for clarification on the amount that was recommended by the Board on Budget and Finance. Business Manager Kuiper clarified that the fiscal policy restricts the senate to funding \$0.15 per mile for one trip.
