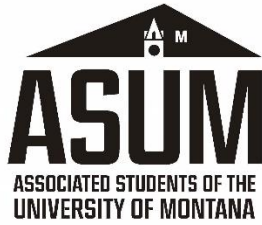

ASUM Senate Minutes
Wednesday, March 20, 2019
Missoula College West Campus, 6:30 p.m.

Chair Welch called the meeting to order at 6:32 pm. Present: Senators Akmal, Anderson, Belcher, Corkish, Glueckert, Grewell, Hanley, Hiatt, Johnston, Milton, Miranda, Nelson, Pablo, Parsons, Paz, Pease, Schei; Business Manager Schafer; Vice President Welch, and President Butler. Senator Borghesani arrived late and was unexcused. Senators Davis and Gregory arrived late but were excused. Senators Koch and Woody were absent and excused. Senators Flanagan and Powell were absent and unexcused.

Minutes from the March 13, 2019 meeting were approved.

Public Comment

- Conlan White, First year law student
 - Discuss SBA fee situation and recent meeting
 - Concerned about the recent SBA meeting
 - Believes that law students should pay the full ASUM fee
 - ASUM did not discriminate against law student groups during this year's budgeting process and has since updated fiscal policy
- Tommy, Missoula College West Campus student
 - West Campus has little administrative support, which puts extra pressure on instructors
 - Encourages Senators and others to come out to West Campus
 - Sent a good message when President Bodnar came to visit
 - Because buses don't come to West Campuses, some students don't want to pay the full transportation fee
- Danielle Pease
 - To talk about the Special Allocation request from J. Doe committee
 - Multiple student groups are collaborating for Sexual Assault Awareness week
 - About 70-100 people last year
- Julianna, West Campus student
 - Since the last time she came to the ASUM meeting, she has seen several improvements

President's Report

- Griz Central Listening Circle will be Friday, March 22, 1-2pm
 - Nothing is clear right now, so students can have a lot of input
 - Executives like a nicer study space
 - Hours of the Lommasson Center also discussed
- Committee Reports
 - Transportation will not operate over spring break
 - More promotion for KRELF, looking for creative ideas
 - For more information about KRELF, go to their website or email Kat Olson at asum.sustain@mso.umt.edu.

- ASUM Legal is looking for ways to inform students during orientation about their legal rights
- ASUM agencies are going to have consistent, rotating ads in the Kaimin next year
- UPC is looking at ways to shape communities of excellence
- Free speech discussions continue. If you have input on the draft, please send it. They are looking for feedback.
- SBA Update
 - 70-30 split was voted first at the SBA meeting, full ASUM fee was second
 - President Butler is meeting with Paul Kirgis tomorrow
 - ASUM position is that law students should pay the full ASUM activity fee, but law students should decide if they pay their own fee also
 - Wants to speak with SBA directly before proceeding with a resolution
- Childcare Update
 - There was a meeting today where recommendations were drafted to send to President Bodnar
 - Information will be public next week, and an email will be sent out to students

Vice President's Report

- Elections Update – Senator Hiatt
 - 19 Senator candidates have registered, 2 executive teams, 1 business manager candidate
 - Would hope to get to 26 by Friday, March 22, at 5 pm, when applications are due
 - Write in candidates will likely get the remainder of the seats. Write in candidates MUST turn in an expense report, even if they didn't spend any money, or else they will not be on Senate
 - If you know of a class where the professor is open to class raps, give it in your classes
- UM Days Friday, March 22 at 8:30 am in UC Theater
- If you propose a resolution, send it only to VP Welch and Secretary Ward, not to the chair of the committee
- Committee chairs should keep VP Welch updated on what happens to resolutions in committee. If they are tabled or failed it can get confusing.
- Senate reports are due April 19. Chairs of each committees also must write committee reports.
 - They will be shared with VP Welch and next year's VP unless specifically requested otherwise
- Committee Updates
 - Glueckert: Motion to add herself to Radio Board. Unanimous.
 - Committee updates approved unanimously.
- VP Welch wants to share Senator hometowns with our lobbyist so that we can target specific Montana senators on the Finance committee
- MAS Update
 - Some executive changes
 - There will be changes to the account structure next year

- Belcher: Online program management info sessions on April 3 and 4 from 2-3pm. These info sessions are specifically for students. Director of summer search committee met and will have interviews after break.
- Davis: Marketing and Outreach is making an elections video tonight. Will advertise write in candidacy after Friday. New screen in SGRC is up and accepting slides.
- Anderson: Grad Council met. Child care will meet in April. J. Doe did not meet this week but is working on transitional housing. Meeting time will change. Met with PEACE committee on Friday to talk about collaboration.
- Parsons: Legal will meet at 2:30 on Friday. Discrimination Grievance committee met today and talked with consultants. ASCRC met on Tuesday and discussed Gen Ed.
- Hanley: R and A will meet on Friday at 5pm. Dean of the Honors College search will meet tomorrow to review applications. Will hold Zoom interviews the week after spring break.

 - Resolution passes 20-1-1.
- SB45-18/19: Resolution Regarding Disbursement of Funds to the Special Allocation Account in Section 11.1 of ASUM Fiscal Policy
 - Hanley: Authorship. Simple majority was chosen to reflect the travel allocation process.
 - Resolution passes 17-4-0.
- SB46-18/19: Resolution Regarding Parking Lot Closures and Reservations Communications
 - Hielt: Amend lines 28, 31, and 34 to add “ASUM requests that”
 - President Butler: Amend line 23 to strike “frequently, no” and add “in some instances”. Seconded.
 - Akmal amends amendment to say “in some instances, no”. Friendly. Amendment passes.
 - BM Schafer: Add Associated Students of the University of Montana before ASUM. Friendly.
 - Grewell: Move to remove s from requests in line 28.
 - Resolution passes 22-0-0.
- SB47-18/19: Resolution Removing ASUM Productions Board from ASUM Bylaws
 - Anderson: Authorship. There is to UMP, so there should be no UMP board.
 - Resolution passes 21-0-1.
- SB48-18/19: Resolution Removing ASUM Productions from ASUM Fiscal Policy
 - Glueckert: Move to amend line 5 to say “ASUM Senator”
 - Passes 21-0-1.

- Schei: Resolution regarding ASUM support for OER initiatives, to be sent to R and A.
