ASUM SENATE MINUTES
November 8, 1995

Chair Shonk called the meeting to order at 6:06 p.m. Present: Lee, Shonk, Thielman, Bear Don't Walk, Carlson, Donnelly, Erickson, Henry, Holtan, Hueth, Iacopini, Ingram, Kelley, Laska, Maloon, Mathern, McColly, Merrick, Rigler, Rusk, Sticka, Swift-Eagle and Ziglar.

The minutes of the November 1, 1995, meeting were approved.

Public Comment

Ben Darrow expressed concerns over Fiscal Policy issues being discussed.

President's Report

- a. Wayne Hogan, Athletic Director, spoke about the athletic program and fielded questions from Senators.
- b. The following slate of committee appointments were offered by Lee and approved by Senate: Grievance - Steve Lypus, Jeanelle Lamphier; Student Complaint - Cory Rigler; Business Benchmarking - Kevin McColly; ASUM Affairs - Sean Maloon; University Affairs - Josh Sticka; SPA Chair Tom Donnelly.
- c. Lee presented his ideas for Fiscal Policy.

Vice-President's Report

- a. Shonk encouraged Senators to come to the ASUM Office at 4 p.m. Sunday for discussion.
- b. Earlier in the week Shonk distributed a quick list for parliamentary procedures and some guidelines for writing resolutions and encouraged Senators to refer to these materials.
- c. SPA will offer a resolution next week opposing credit caps.

Business Manager's Report

- a. Fiscal Policy amendments were explained by Thielman.
- b. Senators may get a manual in Thielman's office on book exchange ideas that he acquired during his trip to Portland.
- c. Henry circulated information about the Pharmacy super tuition being proposed.

Committee Reports

- a. SPA Co-Director Skornogoski reported that SPA worked at registering, informing and getting students to vote. The next project will be financial aid. An idea used last year was a parents' coalition, and that may be pursued again. Curtis Horton, a firm supporter of the family definition, was not re-elected.
- b. Ingram offered the following slate of groups were recognition which Senate approved: Student Recreation Association, The UM Student Chapter of the Society of American Foresters, Humanities Club, Missoula Hang Gliding Association, International Business Students' Association, Geography Club, International Students' Association, Alpha Lambda Delta, Montana Model United Nations, Ask An Alum Program, Buttered Toast Society, Div. Biological Sciences Organization for Advancement of the Graduate Program, Chinese Student Association, U of M Cycling Club, Camas, University of Montana Woodsmen Team, Betterside Rugby Club, Le Cercle Francais (The French Club).
- c. Bear Don't Walk reported that ASUM Affairs met Monday at 4 p.m. and they passed SB13 and SB14 out of committee.
- d. Kelley attended ITPAC today where they discussion about a half million shortfall.
- e. Kelley reported that Library Benchmarking met Tuesday and elected a chair.

- f. Erickson noted that UC Board will meet tomorrow at 7 a.m. and review the survey that was in the KAIMIN.

Unfinished Business

- a. SB12-95/96 Resolution on UC Bookstore Textbook Availability Policy (Exhibit A). It was noted that this resolution didn't go to committee and couldn't be considered. A motion by **Hueth-Henry** to suspend House Rules to consider it passed. A friendly amendment by **Hueth** to insert "ASUM request" after "that" in the third paragraph was accepted. A call of previous question by **Thielman-Henry** passed. Upon immediate vote the resolution passed.
- b. SB13-95/96 Resolution to Require ASUM Senators to Commit One Hour Per Week to the ASUM Office (Exhibit B). A friendly amendment by **Kelley** to change "one" to "three" in the fourth line of the last paragraph was accepted. A friendly amendment by **Thielman** to strike the third sentence in the last paragraph was accepted. A call of previous question by **Holtan-Swift Eagle** passed. Upon immediate vote the resolution passed.

A motion by **Swift Eagle-Donnelly** to adjourn failed.


