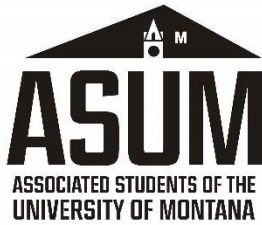

 - ii. Digital accessibility is making content accessible and understandable to all regardless of disability

 - 3. 2012 a UM student filed a civil complaint against the university for accessibility civil rights

- a. General Updates

- i. Food Trucks

- 1. We are going to be bringing food trucks back onto campus
 - 2. Pilot project for spring semester
 - 3. Rotation of food trucks on campus
 - 4. Right now we have three signed up
 - 5. First full week in February they will start WED-FRI they start that rotation
 - 6. Will fit with new schedule of corner store this semester
 - 7. Hopefully will add more vendors when the weather warms up
 - 8. Basing location and hours on our experience on campus
 - 9. They will take Cash, credit, and checks, but they will not be campus credit accessible yet
 - 10. Advertising and marketing will start soon

- ii. Questions:

- 1. Flanagan: Is there any talks of getting the trucks to west campus
 - a. There are not enough students out there to make that feasible
 - 2. Johnston: I support this food truck idea
 - 3. Sladich: I am liking the new look of the corner store, is there any way we can get it open on the weekends?
 - a. The corner store is in transition right now, and we are having conversations about that, so in the short term no, but maybe in the future
 - 4. Tarallo: Is the corner store open for business until 10 or just the seating area.
 - 5. Fulton: As a market employee a lot of students ask about using food plans in the market.
 - 6. Flanagan: Are there still plans toward the wood fire pizza stove?
 - a. It will likely be stone hearth and not wood fire

7. Nelson: Can you elaborate on why the food trucks aren't open during the lunch hour
 - a. Right now, we feel there was too much competition to make it worth it
 8. Johnston: Have you considered food trucks during finals week
 - a. We have tried it in the past but there was not that much business
 9. Tarallo: Food trucks being accessible to other dorms across campus
 - a. If we see a market for it, which we have not in the past
 10. Durnell: Is there a way that you guys plan to counteract the access of the meal plan for the food trucks
 - a. For the food trucks probably not
 11. Kiefer: Do any of the food trucks have vegetarian and vegan options
 - a. Yes
 12. Johnston: What do the revenue numbers look like for the commuter plan?
 - a. We haven't run the numbers yet, but it will probably look similar to the faculty staff plan
 13. Fulton: Would it be possible for the market to take the meal plans on the weekend, when the other options are not open?
 - a. I would have to look into that.
