The visitors and witnesses introduced themselves.

Mr. Zinacker distributed his proposal for the County Commissioners Association, Exhibit A (attached). It is a new Article except Section 2. Miss Speer asked if he felt that these provisions provide specifically for the merging of counties and Mr. Zinacker said they did, in Section 4.

It was decided to have Mr. Zinacker go over the proposal. He said Section 1 primarily provides for maximum self government for cities, towns and counties to provide as they see fit for their own localities. Section 2 retains present county seats except if change is voted by a majority of the people. Section 3 defines what units of local government are. Section 4 provides for any type of local government to be set up by the Legislature which would give guidelines. Section 5 sets up residual power for local governments. Section 6 allows for the cooperation or consolidation between local governments.

A question and answer period followed.

The Chairman introduced Mr. Pierce from Great Falls. He will testify later in the week.

Mrs. Jean Anderson, League of Women Voters, State Organization, testified pext. Her prepared statement is attached (Exhibit C). A question and answer period followed her testimony.

The Chairman introduced George Schoeder, Cascade County Treasurer, President of County Treasurers Association, and Mrs. Mary Westermark, Treasurer of Toole County, and Secretary of the Association.

The meeting recessed at 11:55 a.m., to reconvene at 2 p.m. The question and answer period with Mrs. Anderson continued at 2 p.m.

The Chairman reviewed the schedule for the next few weeks. He said our joint hearing with the Education Committee to discuss County Superintendents of Schools has been scheduled for Tuesday, February 3 at 1:30 p.m. No place has been set for the hearing yet. He also stated the procedure for minority reports from the Committee, stating that 3 members can have a minority report.

There was a short discussion on when to have the Constitution placed on the ballot. Five want it on the November ballot, three on the June ballot, and two in special elections.

The Chairman discussed the Citizen Suggestions (list attached, Exhibit E). Mr. Holloron will prepare a summary for the Committee.

Mr. Earl Holman, County Commissioner from Butte, was present. He gave testimony to the effect that the prohibition on gambling should be removed from the Constitution. He would like this left up to the localities. This is in the jurisdiction of the General Government and Constitutional Amendment Committee and he was referred to that room.

Miss Speer mentioned the suggested Colorado Local Government Article (attached Exhibit D).

It was decided that Mr. Arness should finish his commentary and answer questions on Delegate Proposal 9. He did so, and an hour discussion followed on the effects, implementation, and other pertinent questions followed.
