The Spirit Squad Class is a special class for those members representing the cheer squad, dance team and mascot each semester. The Spirit Squad program is considered part of the Athletic Department at the University of Montana. It is managed by the Spirit Squad Program Director, who reports directly to the Deputy Athletic Director for External Operations. This program is a division of the marketing department. These students have mandatory practice times each week, as well as cheer all football, volleyball and men's and women's basketball throughout the year.

Practice for each team is designated by the head coach and is no less than 3 days per week for 2 hours.

They must abide by the Spirit Squad Policies and Procedures handbook and sign a contract each year in order to be a member of the team. Team policies are at all times enforced by coaches and the director.

Attendance is monitored by coaches and reported to the director each semester. Grades are based on attendance, performance, compliance of team policies and procedures. Midterms and special assignments are also given by the Director and coaches once a year.
