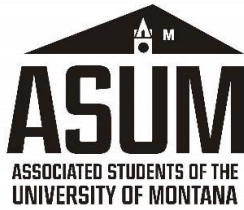

## **4. PUBLIC COMMENT**

a. **Meghan Stark, President of the University Faculty Association** – I am here to discuss a fund the faculty union applied for to raise funds for emergency aid. The application is currently live. You can reach out to me directly for more info. We applied for seed funding that you can apply for here, but the original fund at Temple University has run out. We've found additional funds and have a good amount of money in this fund, so we anticipate the need will be great. We've also asked faculty members to donate what they can. This is called the FAST fund, and it means Faculty and Students Together, because you are the reason we are all here teaching you. We care deeply about you as members of our community. Your leaders have

been fierce and articulate during this. You have been represented far beyond what I expect from anyone. You have real leaders. This wouldn't happen if your president wasn't so persistent.

- b. **Alyssa Stokovich** – I am here urging you to vote in favor of my resolution to help put out resources on sex trafficking in Montana. We want to increase awareness and education about this to help identify and prevent trafficking in this state. This is the best way to get people aware of the topic. 4 million adults were victims of sex trafficking in the US last year and a million were children. We want to put specific resources to help identify red flags for someone who might be in those situations and to let them know who they can contact. This is pretty simple and barebones. We are just asking the university to do something.
- c. **Kyle Yoder, Students for Sensible Drug Policy** – We are focused on harm-reduction strategies to reduce the negative consequences of drug use and to work with the university to create a reasonable drug policy that does not create fear in stressful situations. We are supporting an amnesty policy and will be proposing a resolution supporting this to the university in the fall. We also want to distribute fentanyl tests to ensure that people who use hard drugs do not overdose by using drugs cut with fentanyl. We are partnering with the Open AID alliance for training and to reduce liability for distributing tests. We also want RAs to be trained in how to handle a potential overdose in the dorms. We want to make campus a safer place and save lives. Funding from the budget committee was much less than we need, but we hope we can secure more. I'm looking forward to working with you next year.
- d. **Michael Layeux, SSDP** – This is deeply important to me that we create a support system to mitigate the damage drugs can do. We need amnesty on campus to secure the safety for our students. We need to be able to distribute tests and get RAs trained so we can actually provide real services to people on campus. We can illicit real change. We have organized our budget to prioritize outreach during this time of remote learning. We are hoping to accomplish a lot with the help of ASUM. We are happy to answer your questions.
- e. **Cierra Anderson** – I was hoping to start a discussion on the 4 vote threshold for elections for write-ins. Doesn't seem like it's within the Senate's purview and seems like an issue with how few people ran for Senate this year.

### **Relations and Affairs**

The Relations and Affairs Committee met on Sunday, April 26th to discuss two final resolutions for the year; Resolution Amending the ASUM Bylaws to Address Executive Candidate Appearances within ASUM Promotional materials, and Resolution Supporting the Creation of Transitional Housing for Survivors of Domestic Violence at the University of Montana. The first resolution had some amendments that would include the ASUM website as a platform where ASUM Executive Candidates shouldn't appear, and made it so a candidate's written likeness could not be promoted through ASUM. There was substantial conversation regarding if Senate candidates should be barred from the same. This passed by a 5-2-0 vote. The next resolution did not see any amendments and passed by a unanimous vote. The committee talked minimally

### **Zero-Waste Advisory Board**

Zero-Waste met for the last time this semester on Friday, April 17th. We reviewed the bylaws and compiled a list of changes we want to see made in the coming semester to ensure the Board is restructured to better engage students, faculty, and staff present on the Board. We also want to improve coordination among various ASUM and university agencies for the next year. In the future we are hoping to host a zero-waste sports event, such as a basketball or volleyball; eventually we would like to see a zero-waste football game as well.

We talked about the possibility of Fall 2020 semester being online and how we would want to keep Board members actively thinking about zero-waste using resources from PLAN. We hope that Zero-Waste can expand and improve its efforts in the coming year.

### **Elections Committee**

- a. Nelson-Johnston Motion to repeal the cap on write-in candidates the Elections Committee has placed
  - a. Nelson: There is nothing in the governing documents that allows this to happen. This will go to the review board if allowed.
  - b. Anderson: I think the interpretation was based on the lowest number an official candidate received, but we need to fill the Senate for next year
  - c. Glueckert: I had spoken with the advisors and advocated for lowering the threshold to create a full senate. Next year, elections needs to go through the documents and have these conversations earlier.
  - d. Parsons: How should the senate be filled in the case where we don't have enough candidates?



- i. Nelson: calling the write-ins randomly to gauge who is interested?
- ii. Parsons: This is something a constitutional review board should handle, not the Senate, but that might be a difference of opinion.
  - 1. Anderson: So I spoke with Lou, and because we are not changing the results, we can just do it, and then move to a constitutional review board to correct what we do from here.
- e. Tarallo: We are violating the rule right now, and hopefully the proportionality resolution will address this. To be honest, I also wonder how many write-ins actually want to serve. I think a threshold should be higher honestly. I do not think we should overturn the decision of the committee.
- f. Johnston: quoted the specific section that says the senate needs to have 26 members. Otherwise we are in violation of our governing documents.

How MMUN gets funded has pretty much been dependent on who is business manager and the amounts change every single year. Recently, we've amended our constitution to be more compliant and hopefully address the concerns with this student group. I don't think this shows favoritism, it shows flexibility.
