- Hi everybody, there are a few things that I would like you guys to know. So, we do have COVID testing available on campus. There are two forms that you can receive at Curry Health Center. The first is if you are symptomatic, you can call us up and tell us that you want to get tested. What we will do, if you are not too sick, we will bring you outside the Curry Health Center and get you tested, and we can get results within an hour. We are one of the few in the state that can do this. We had to institute a \$25 charge for the test, and I hate that we had to do this but we as a health facility are struggling financially but we are doing our best. You can send that cost to your insurance company and post insurance companies do pay off the full price. I want you all to be aware of our services and that we are here to provide for you, and I welcome any questions, comments, or concerns that you may have.
