This syllabus is a written contract between you and myself, your instructor. Please read it carefully and contact me if you need further clarification. If you decide to continue in this course, it means that you have thoroughly read the syllabus and accept all requirements as stated.

Content Notification: "Art scholarship and art practice along with teaching and learning involve a critical exploration of ideas, theories, art-making practices, and art movements that encompass such things as the human body, sexuality, race, gender, religions, and cultures. This course can touch upon any of the above categories with an expectation that students will actively participate in all course assignments, discussions, and tests. Given this information, it is the student's obligation to determine that the requirements conflict with his or her core beliefs. If the student determines that there is a conflict with his or her beliefs, one of the following actions needs to be taken: 1) drop the class before the last day to drop a course without penalty; 2) meet with the instructor within the first week of classes to determine if an accommodation can be made. (Note, faculty, are not required to grant content accommodations.)"

Course Materials

Textbook

This class requires no textbook. Readings will be drawn from articles from various sources and will be provided by the instructor and accessible through Moodle.

Recording or Distribution of Course Materials

Students who wish to make available any portion of the class to individuals outside of the class must speak with the instructor ahead of time. Course materials are for personal use only. They may not be shared, copied, uploaded to the Internet, and/or distributed without written permission from the instructor as well as any student whose work appears.

Course Description

This course assists students who are studying art and design to learn visual communication strategies and solutions to image-making problems through the media of their choice. Students are encouraged to experiment with techniques though concept-driven coursework. Students will be guided through exercises that will help them develop a personal artistic style. In addition, the course will give students insights into the demands of a professional illustration career.

Prerequisites: none. Audit available.

Course Outcomes

Upon successful completion students should be able to:

- Utilize visual metaphor to represent an idea or concept.
- Provide a variety of visual solutions that communicate a specific idea or concept.
- Identify their own personal artistic style and make use of exercises and techniques to further develop their personal style.
- Understand the demands and breadth of the field of illustration.

Format and Course Requirements

Students will need to be able to access the online Moodle learning environment regularly throughout the week, no less than three times each week but likely more. Students will need to be ready to choose the media that they wish to use for this class. Students are expected to be self-motivated, curious about their artistic journey, and ready to push their artistic practice to the next level.

Sketchbook Exercises (280 Points)

Students will maintain a physical or digital sketchbook. Each week, students will have sketchbook exercises to complete. These exercises will help the student develop their skills and encourage exploration of techniques and ideas. The sketches for each week will need to be photographed or scanned if they aren't already in an electronic format and uploaded to Moodle. Detailed exercise descriptions and rubric can be found on Moodle.

Online Sketchbook Discussions and Critique (210 Points)

Students will participate in online critique of each other's art assignments. You will be required to share images of your artwork and discuss challenges and solutions to the sketchbook exercises and assignment prompts. You will need to be open to feedback and ready to push the boundaries of your own art practices.

You will also need to critique other students' artwork. You will be required to share your opinions of their artistic choices and suggest areas for further improvement in a way that supports and validates the other students in the class.

Discussions should be a safe space for sharing ideas. Write and respond to each other with empathy and respect. A detailed rubric is available on Moodle.

Assignments (300 Points)

Students will be given four assignments over the course of the term. Each is worth 75 points. These assignments are aimed at giving students opportunities to explore various specialties within the field of illustration. Students are encouraged to find creative solutions to the assignment prompts. Detailed assignment descriptions can be found on Moodle, along with detailed rubrics.

Midterm and Final Projects (210 Points)

Students will be given a more in-depth assignment for your midterm and for your final. Each is worth 100 points, with an additional 10 points given for part of the work on the midterm project. Detailed assignment descriptions can be found on Moodle, along with detailed rubrics.

Make-Up Policy

Make-Ups without late penalties will only be given in the case of documentable medical issues or family emergencies. If you have a known time conflict with the class dates, you must let me know at least 2 weeks in advance. Class assignments can be completed late with a 10% deduction in grade per day. Special circumstances can be explored with the instructor on a case by case basis.

A student may repeat a course for a higher grade under certain conditions. All grades earned will appear on the transcript. The most recent grade earned for a course will be calculated into the GPA and the total credit hours earned; all other grades earned for that course will be excluded from the GPA and the credit hours earned. If a course can be taken more than once for credit, the oldest grade for that course will be excluded only when the repeat limit is exceeded.

Extra Credit Policy

Extra credit opportunities may be offered throughout the term to all students at the discretion of the instructor. Extra credit will not be offered to individual students. Students should avail themselves of extra credit opportunities if they arise, but should not depend upon them to achieve their desired grade.

Credit / No Credit Policy

If a student wishes to take the course for no credit, it must be arranged with the instructor. Students taking the class for credit will be given priority in enrollment.

Drop / Withdraw Policies

You can drop a class from your schedule and receive a full refund as long as you do it before the drop deadline. Even if you don't attend the class, you must drop the class or you will be held liable for the charges on your account. The class will not show up on your transcript.

If you wish to withdraw from a class after the drop deadline, you can do so from the Registration Office. You will not receive a refund and you will receive a "W" on your transcript, indicating that you have withdrawn from the class. This will not effect your GPA.

After the withdrawal deadline, the instructor must assign you a grade for the course.
