8 Whereas, student groups at the University of Montana require projectors for use at
9 various student-driven events;

10
11 Whereas, most student groups at the University of Montana do not have their own
12 projectors;

13
14 Whereas, these student groups must then rent a projector from the IT department or Event
15 Planning which costs fifty dollars for a full day of use, and twenty five for a half day of
16 use;

17
18 Whereas, the Associated Students of the University of Montana (ASUM) represents and
19 supports student groups and student group interests;

21 Therefore, Let It Be Resolved, that the ASUM Senate charges the ASUM President, Vice
22 President and Business Manager with purchasing a minimum of one and a maximum of
23 two projectors which will then be available to ASUM student groups for the purpose of
24 renting and using them during meetings;

25
26 Therefore, Let It Be Further Resolved, that the ASUM Business Manager in consultation
27 with the ASUM President and Vice President shall set guidelines for the rental of said
28 projectors in accordance with Fiscal Policy.
