DISCUSSIONS:

Delegate Erdmann of Great Falls appeared before the committee in support of her proposal #96. She was thanked and excused by the Chairman.

Oliver LeFevre, a real estate man from Billings, was the next witness. He testified that he also has property in Sheridan and that he wants the state to keep land under its control.

The next witness was John Ray of Hamilton, a newcomer to the state who is planning on going into private business and is also a teacher. He recommends the committee do all they can to preserve local government in regards to water rights.

Dr. Clancy Gordon of the University of Montana at Missoula showed a movie on the environment in Montana. The Bill of Rights Committee was also present for this movie. He then spoke on the coverage of the movie and the necessity for natural resources to be preserved for the future generations.

Bill Baird, a real estate man from Billings was the last witness this day. He said that control of land by the state is not what is needed. He was thanked and excused by the Chairman.
