8       Whereas, the Associated Students of the University of Montana (ASUM) Childcare Oversight  
9       Committee is tasked with overseeing ASUM Childcare, and helping the ASUM Childcare  
10      Director on issues related to ASUM Childcare and its operations;

12      Whereas, recognizing the potential of an Infant Care Center opening in the Fall of 2014, the  
13      2013-2014 ASUM Childcare Oversight Committee and the current ASUM Childcare Director  
14      believe that the Committee should be chaired by someone who is passionate about the cause;

16      Whereas, Article IV, Section 18, Subsection C of ASUM bylaws currently reads:

18                    “C. The ASUM Childcare Oversight Committee shall be chaired by an ASUM Senator.”

20      Therefore, Let It Be Resolved, that Article IV, Section 18, Subsection C of ASUM bylaws be  
21      amended to read:

23                    “C. The ASUM Childcare Oversight Committee shall be chaired by an ASUM Senator or  
24                    Student-at-Large chosen by the ASUM President, in conjunction with the ASUM Vice  
25                    President.”
