9       Whereas, The Associated Students of The University of Montana (ASUM) represents the  
10       University of Montana student body and aims to further the interests of students who seek to  
11       study under a unique and diverse curriculum;

12  
13       Whereas, students across campus have expressed concern for the future of the academic majors,  
14       minors, and options they are studying in departments such as Anthropology, Political Science,  
15       Native American Studies, Liberal Studies, Modern and Classical Languages and Literatures, and  
16       Geography;

18       Whereas, ASUM appreciates that academic departments have only taken a 1% cut across the  
19       board;

20  
21       Whereas, in a time of budgetary crisis some departments are losing students because they are  
22       unable to provide what students need, causing those students to take their tuition money  
23       elsewhere;

25       Whereas, many departments have had to leave professor positions empty, giving students fewer  
26       course options, not only in their major requirements, but in general education categories as well;

27  
28       Whereas, some of the aforementioned departments are consistently offering elective courses  
29       while, because of empty professor positions, required courses for majors, options and minors are  
30       not being offered with enough frequency to effectively aid students;

31  
32       Whereas, there are departments in which empty professor positions are limiting the options  
33       associated with a major that a student may take, even if they came to the University of Montana  
34       to study a such program;

35  
36       Whereas, given that there are empty tenure seats in some departments, fewer graduate students  
37       have been accepted, impacting the future of not only unique but also highly desirable programs;

38  
39       Whereas, due to the smaller amount of professors on the tenure track, students are experiencing  
40       inadequate advising;

41  
42       Therefore, Let It Be Resolved, that the ASUM encourages department chairs and the Dean of the  
43       College of Humanities and Sciences to fund positions that allow both undergraduate and graduate  
44       students the education they came to the University of Montana to study;

45  
46       Therefore, Let It Be Further Resolved, that ASUM encourages department chairs and the Dean of  
47       the College of Humanities and Sciences to evaluate courses to determine the feasibility of those  
48       courses being taught by adjunct professors or graduate students qualified to teach said courses;

49  
50       Therefore, Let It Be Further Resolved, that ASUM supports strategic budget cuts, congruent with  
51       student demand of courses and programs, particularly such that department chairs and the Dean

52 of the College of Humanities and Sciences work to hire faculty capable of teaching graduate and  
53 undergraduate programs in classes that are required courses for an academic minor, major, or  
54 option;

56 Therefore, Let It Be Further Resolved, that a copy of this resolution be sent to Perry Brown,  
57 Provost, Dr. Gilbert Quintero, Chair of the Department of Anthropology, Dr. Ramona Grey,  
58 Chair of the Political Science Department, Dr. David Beck, Chair of the Native American Studies  
59 Department, Dr. Stewart Justman, Chair of Liberal Studies Program, Dr. Jannine Moutauban, Co-  
60 Chair of the Modern and Classical Languages and Literatures Department, Dr. Christine von  
61 Reichert, Chair of the Geography Department, and Chris Comer, Dean of the College of  
62 Humanities and Sciences.
