8       Whereas, the University Center (UC) leases space to private businesses;  
9

10       Whereas, these private businesses, such as Pizza Hut and Jus Chill'n, offer their employees the  
11       ability to receive gratuity via a "tip jar";  
12

13       Whereas, Ui Cha is a private business who leases space on the second floor of the UC;  
14

15       Whereas, currently employees of Ui Cha are not allowed to receive gratuity for their work;  
16

17       Therefore, Let It Be Resolved, that the Associated Students of the University of Montana  
18       (ASUM) requests that employees of private businesses such as Ui Cha be afforded the same  
19       opportunity as all other private businesses within the University Center to receive gratuity for  
20       their labor.

22       Therefore, Let It Be Further Resolved, that the ASUM Senate charges the ASUM Executive  
23       Team and the University Center Board to work together with all necessary stakeholders to see  
24       this accomplished.
