9           Whereas, the Associated Students of the University of Montana (ASUM) is bound by its Fiscal  
10          Policy;

12         Whereas, ASUM Fiscal Policy Section 10, subsection 7 reads:

14         “10.7 The organizations listed below, which are funded in part or whole by the ASUM Activity  
15         Fee, may meet with the Board once each semester should either the Board or the organization  
16         request such a meeting. The purpose of these meetings shall be to update the Board on budgeted  
17         activities. These meetings may be attended by the Accountant and/or Office Manager in order to  
18         help clarify any budget problems. The Business Manager shall then report the Board's findings  
19         and recommendations to the Senate.

36         Therefore, Let It Be Resolved, that Section 10, Subsection 7 of ASUM Fiscal Policy be amended  
37         to read:
