6:00 p.m.

Chairman Wickstrom called the meeting to order at 6:07 p.m. Present were: Hollenbaugh, Wickstrom, Rosenthal, Barber, Boston, Dale, Greteman, Hargesheimer, Hummel, Krause, Kuntz, Lewis, McCleary (6:11), McKay, Oliver, Rathert, Redhorn, Singer, St. Peter, Tinsley, Wetterling and Zink.

The minutes of the February 12th and 19th meetings were approved as written.

Public Comment

Elizabeth Pfaff and Danna Jackson spoke in opposition to 24-hour gun-carrying on campus.

Sgt. Dick Thurman of Campus Police and Peter Ephramson spoke in favor of 24-hour gun-carrying on campus.

President's Report

Hollenbaugh announced Senator Winnie West's resignation from Senate.

A letter was sent to Mayor Kemmiss and City Council Members requesting some compromise and easing up on the residential parking plan (copies to campus officials). Interested persons may see a copy of the letter in the ASUM office.

Vice President's Report

Wickstrom expressed disappointment with some Senators' early departure from Senate meetings and asked for prior notification.

Committee reports from Senators serving on committees are expected at the Senate meetings or in written form to Wickstrom.

Ken Willett from Campus Security discussed the gun issue and answered questions.

Business Manager's Report

The Budget & Finance Committee had a tie vote on the injunction issue.

Senate approved a \$640 special allocation request from the Student Action Center for recycling.

Senate approved a \$1000 special allocation request from the Symphonic Band for a conference tour.

Senate approved a \$270 special allocation request from Spurs for their Spring retreat.

A letter has been sent to Phoenix outlining the requirements they must meet, as passed by Senate, for them to continue operating after March 4.

Rosenthal reported on the status of Programming. They have received over \$12,000 in grants and are doing well.

Committee Reports

John Kruase reported that the Ad Hoc Computing Committee is studying the restructure of the University computer system. Staff have travelled to other universities and reported.

Ed Zink is reviewing ByLaws for needed clarifications.

Greg Lewis explained that he refrained from reporting on the Dahlberg reseating plans out of courtesy to Bill Moos, Athletic Director, who made a presentation at last week's Senate meeting.

Brittney McKay reported that the new UC mall usage policy would go into effect Spring quarter.

Old Business

- a. Senate passed the resolution requesting a \$4,000 General Fund allocation for injunction costs (Exhibit A).
- b. Senate passed the gun resolution with a vote of 15-6 (Exhibit B).
- c. Senator McKay tabled the Space Allocation Resolution.


New Business
