Public Comment

Jonathan Blaine praised the STS program and encouraged Senate to give them additional funding to finish out the year.

President's Report

Hollenbaugh made the following resignation announcements: SAC Director Glenda Skillen to student teach in Billings; ASUM Business Manager Paula Rosenthal to take a position in Alaska; Senator Stacey Hargesheimer for personal reasons.

Senate ratified the following replacements: Eric Scheuring as SAC Director; Eric Hummel as ASUM Business Manager.

Senate agreed to allow the officers to submit Senate appointments for approval and bypass Senate interviews to fill the four vacancies, since there will be so few meetings left in this year's term.

Hummel announced that STS is seeking additional funds to finish the year. He and Marleen Bain will be meeting with the UM administrators to ask them to split the cost with ASUM.

ASUM will be looking for a way to fund a rape survey which will cost \$5,000.

Budget and Finance has two openings due to Hargesheimer's resignation and Hummel's appointment to Business Manager.

Bill Rathert announced that election packets are ready for pickup.


