Unexcused were Garlow and Wetterling.

The minutes of the May 6 meeting were approved as written.

(Public Comment moved to end of agenda tonight only.)

#### **President's Report**

On the bulletin board is a copy of the lawsuit addressing the residential parking permit district. The suit was filed Tuesday.

Hollenbaugh stressed the need for Senators to get information out to their constituencies on the referendums to be voted on next week.

An open forum on enrollment management will be held Thursday, May 14, from 7:30-9 p.m. in the Law School Library. GO!

#### **Business Manager's Report**

- a. Senate passed the "1991 ASUM Programming Deficit Repayment Act" (Exhibit A).
- b. Senate chose to uphold Budget and Finance's decision not to approve Black Student Union's request to move remaining account monies funds to Entertainment for recruiting party.

#### **Committee Reports**

Jeff St. Peter reported on the Student Affairs Advisory Committee, citing concern that education on the Campus Recreation fee referendum is not getting out. The feedback on the fee appears to be very negative. St. Peter stressed the need for Senators to get out as much information as possible. Another concern is with the lack of academic achievement in the family housing community.

Publications Board met on Wed., May 13, and will be selecting the Kaimin Editor and Business Manager for next year.

The Board on Member Organizations received Senate's ratification for recognition of the Western Montana Mountain Rescue (Training) Unit.

Julie Kuntz reported that the surveys from the Rape and Sexual Assault Task Force have been sent out. She received hers and thought it was well done.

Pat McCleary reported that the Auxiliary Services Committee sent a letter to President Dennison regarding possible improprieties in account transfers. See Pat for more information.

Randi Erickson of The Kaimin announced that biographical sketch forms will be available in the ASUM office for Senate candidates. They should be turned in at Journalism 204 as soon as possible so that an article can run in the paper next Tuesday.

Brittney McKay reported that Student Union Board is sitting in on food service director finalist interviews. The Debit Card Committee has been renamed as the All Campus Card Task Force. See Brittney for more details on that.

#### Public Comment

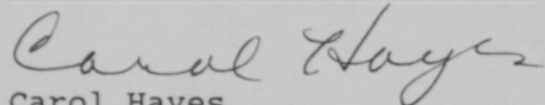

1992 ASUM PROGRAMMING DEFICIT REPAYMENT ACT

The FY92 ASUM Programming deficit of \$46,000 shall be repaid through the following plan:

1. \$10,000 from account 7011 (reserve fund) shall be applied to the deficit and reverted to the ASUM General Fund.
2. All carryover from ASUM Programming FY92 shall be reverted to the ASUM General Fund.
3. Any remainder of the deficit shall be deduced from the FY93 budget and reverted to the ASUM General Fund, up to a maximum amount of \$5,000.
4. All remaining deficit monies shall be repaid by the end of FY93.
