Mr. Jay W. Preston, President, Ronan Telephone Company disputed any constitutional establishement of matters concerning the public service commission. Exhibit #1

Mr. Edwin S. Booth, Attorney for the Montana Railroad Association opposed delegate proposal #76. Exhibit #2

Mr. C. M. Wall, representing the Montana Citizens Freight Rate Association spoke in support of establishing one commissioner for the Railroad and Public Service Commission, and was in support of supporting the commission with adequate staff. United States Senator Lee Metcalf spoke on proposal #76 and said he was in support of the basic rights of the consumer in regard to public utility regulation as constitutional issues. He cited those rights to be the right to be informed, to be heard, and to choose. Exhibit #3

Seldon S. Frisbee, Attorney for Cut Bank Gas Company questioned the philosophy expressed in proposal #76. Exhibit #4

Joe L. Curtis, representing Hysham Telephone Company opposed delegate proposal #76. Exhibit #5

Ian B. Davidson, President D. A. Davidson Co. outlined the
detrimental results which Montana Utilities would experience if
proposal #76 were adopted. Exhibit #6

Paul J. Briesh, General Manager, Treasure State Telephone Company suggested the harmful results he felt might occur for individual telephone companies operating in Montana if proposal were adopted. Exhibit #7

Ward F. Junkermier, Certified Public Accountant outlined his opposition to proposal #76. Exhibit #8

The hearing was adjourned at 12:40 p.m. and a committee meeting was established for 3:00 p.m. on the same day.
