9       Fiscal Policy;

11       Whereas, ASUM Fiscal Policy Section 6, Subsections 6.2-6.2.2 states:

13               “6.2 Any organization which conducts an event, activity, or program funded with  
14               monies originating in whole or in part with the ASUM shall provide on any program,  
15               poster, or other advertisement or promotional material, a credit referring to the partial  
16               or total funding by the ASUM. Examples of such credit shall include at least one of,  
17               but are not limited to, the following:

18               6.2.1 Presented by (organization), an organizational member of the Associated  
19               Students of the University of Montana.

20               6.2.2 An official ASUM insignia authorized by the Senate.”

21       Whereas, this policy is rarely followed and never enforced;

23       Therefore, Let It Be Resolved, that ASUM Fiscal Policy Section 6, Subsections 6.2-6.2.2  
24       be stricken from Fiscal Policy;

26       Therefore, Let It Further Be Resolved, that Fiscal Policy numbering be updated to reflect  
27       the changes.
