8	Whereas, the Associated Students of the University of Montana (ASUM) represents the students
9	of the University of Montana and the Missoula College;
10	
11	Whereas, ASUM is obligated to take action on items and programs that are supported by the
12	majority of the student body;
13	
14	Whereas, ASUM Executives and Senators serve only a one-year term;
15	
16	Whereas, the Montana State Board of Regents (BOR) only accepts fee increase proposals on a
17	biennium basis (every other year);
18	
19	Whereas, student-driven fee initiatives have been voted on by the student body as a whole and
20	are only brought to the BOR if a majority of the student body supports said fee initiatives;
21	
22	Whereas, ASUM leadership may not be the same from year to year, and there is no continuity
23	that would guarantee a fee supported by the students that was brought to the BOR;
24	
25	Whereas, some fees supported by students are for programming that would fulfill an immediate
26	need and cannot wait for the biennium;
27	
28	Whereas, students of the Montana University System should have as much say as possible in
29	what fees they pay, or do not pay;
30	
31	Whereas, if a fee initiative is supported by the student body in a freely held election it would be
32	inappropriate to deny students the ability to support the programming they voted for;
33	
34	Whereas, students in the Montana University System are capable of making decisions that affect
35	their finances for themselves;
36	
37	Therefore, Let It Be Resolved, that ASUM encourages the Montana State BOR to allow for
38	annual fee proposals for student-driven fee initiatives, and only for student driven fee initiatives;

40	Therefore, Let It Be Further Resolved, that a copy of this resolution be sent to: the Montana		
41	Associated Students; Clayton Christian, The Commissioner of Higher Education; Royce		
42	Engstrom, the President of the University of Montana; Rosi Keller, the Associate Vice President		
43	of Administration and Finance; and each individual member of the Montana State Board of		
44	Regents.
