DISCUSSION:

The seventeenth meeting of the Revenue and Finance Committee was called to order by Vice Chairman Maurice Driscoll in the temporary absence of Chairman Sterling Rygg.


The members heard testimony from Delegates Magnus Aasheim and Max Conover on Proposal #119, setting aside certain levies for grass conservation and hail insurance. Delegate Jerome Loendorf also appeared on his Proposal #173, exempting totally disabled veterans from taxation. John Cadby, executive director of the Montana Automobile Dealers' Association, appeared to testify on behalf of #66, introduced by Delegate John Schiltz, which sets up a fee system for licensing motor vehicles.

The committee then considered a rough draft of a proposed taxation article, section by section. All sections were tentatively adopted, with the exception of Section 3, which many felt needed reworking; Section 4, which needed rewording; and Section 5, which was amended to include the word "religious" after the word "actual".

The committee then decided to table the rough draft until after it had met in joint session with the Education and Public Lands Committee during the afternoon.

The meeting was adjourned.


