8       Whereas, employees of The Associated Students of the University of Montana (ASUM) are  
9       bound by ASUM Personnel Policy;

10  
11       Whereas, the ASUM Personnel Policy outlines pay scales and job descriptions for the majority  
12       of ASUM student employees;

13  
14       Whereas, the ASUM Student Resolution Officer's (SRO) hours were more than doubled from 30  
15       per month to 80 per month in the Spring of 2015 due to SB66-14/15;

16  
17       Whereas, this was done to reflect the time that the SRO supposedly worked at the time;

18  
19       Whereas, the realistic time commitment for the position is 60 hours per month;

20  
21       Whereas, a change in the SRO base hours from 80 per month to 60 per month would save  
22       ASUM approximately \$2172.00 per year;

23  
24       Whereas, to effectively attract qualified candidates, the ASUM Senate should consider raising  
25       the base pay, rather than the base hours;

26  
27       Therefore, Let It Be Resolved that the ASUM SRO base hours will decrease from 80 hours per  
28       month to 60 hours per month;

29  
30       Therefore, Let It Further Be Resolved, that this change will go into effect immediately;

31  
32       Therefore, Let It Further Be Resolved, that any relevant section of ASUM Personnel Policy be  
33       amended immediately to reflect these changes.
