12 *present an annual report identifying the achievements and areas of potential growth of*
13 *the administration to reflect current student needs.*

14 *F. The ASUM Legal Board, in coordination with the ASUM Productions Director shall*
15 *present a full evaluation and a specific five-year strategic plan to address identified*
16 *student needs every five (5) years.*

18 Whereas, Legal Board does not oversee UM Productions;

20 Whereas, this is clearly a typo;

22 Whereas, the role of Legal Board is to oversee ASUM Legal Services;

24 Therefore, let it be resolved, that Article IV, Section 24, paragraphs E and F shall be amended to
