8   Whereas, The Associated Students of the University of Montana (ASUM) is bound by its Fiscal  
9   Policy;

11   Whereas, Subsection 14.2.2 of ASUM Fiscal Policy states:

12                                   *Only those groups in the Academic/Honors Organizations, Student Service*  
13                                   *Organizations, Student Support Organizations, Interest Organizations, and Student*  
14                                   *Programs categories are eligible for funds from the Special Allocation - Travel account,*  
15                                   *the exception being the Emergency Union Account.*

18   Whereas, this segment of text is ambiguous and potentially exclusive to certain student groups  
19   that are recognized by ASUM;

21   Whereas, ASUM has a duty and obligation to clarify and define its governing documents to  
22   appear more cohesive;

24   Therefore, Let It Be Resolved that Subsection 14.2.2 of ASUM Fiscal Policy be amended to read  
25   as follows:

26                                   *Only Student Groups recognized by the Associated Students of the University of Montana*  
27                                   *(ASUM) are eligible for funds from the Special Allocation - Travel account, excluding the*  
28                                   *Sports and Music Unions, as these groups have their own Emergency Union Account for*  
29                                   *this purpose.*
