8       Whereas, the *Rules and Regulations for the ASUM Legal Services Program* currently prohibits  
9       ASUM Legal Services from providing legal services to anyone who is not an Associated Students  
10      of the University of Montana (ASUM) fee paying student;

11  
12      Whereas, Legal Services maintains a cadre of legal experts throughout the year, even during  
13      times when student demand for ASUM legal services lightens, such as over summer break;

14  
15      Whereas, the ASUM Legal Services Director has expressed interest in allowing ASUM Legal  
16      Services to serve non-students, such as University of Montana (UM) staff, during these times;

17  
18      Whereas, this would not cost ASUM or ASUM Legal Services any additional money or  
19      resources, and in fact could increase revenue;

21      Whereas, this would not interrupt the provision of legal services to fee paying students;

23      Therefore, Let It Be Resolved, that the following language be added to *Section I, Member*  
24      *Eligibility to Use Plan* of the *Rules and Regulations for the ASUM Legal Services Program*:

26                   *7: At the discretion of the ASUM Legal Services Director, in cases where it would not*  
27                   *interfere with the provision of legal services to fee-paying students, ASUM Legal Services*  
28                   *may provide services to UM faculty and staff. Anyone served under this provision must*  
29                   *be assessed an additional fee on top of any other payment made, determined by Legal*  
30                   *Services, which shall be no less than the current ASUM fee.*

32      Therefore, Let It Be Further Resolved that a copy of this resolution be sent to Annie Hamilton,  
33      Director of ASUM Legal Services.
